The Negotiations Committee held a meeting on **Wednesday, March 6, 2019**, in the Conference Room at the District Central Office located in Buxton, Maine. Present were Committee members Robert Deakin, Trevor Hustus, and James Moses. Also present were Paul Penna, Superintendent of Schools; Julie Bruni, MSAD 6 Board Chairperson; Jennifer Barschdorf, Human Resources Manager; and Hedy Smith, Executive Secretary.

Mr. Moses called the meeting to order at **4:31 p.m.**

1. Executive Session Pursuant to 1 MRSA § 405 (6)(d) to Continue Negotiations with the MSAD 6 Administrative Association

The Committee chose to offer the date and time of Monday, March 11, 2019, at 5:00 p.m. in the Central Office Conference Room. Mr. Moses asked Ms. Smith to contact Ms. Crosby.
