SUPERINTENDENT SEARCH COMMITTEE MEETING

The Superintendent Search Committee meeting was held on Monday, February 14, 2022, in the Central Office Conference Room located at 94 Main Street in Buxton. Committee members Nathan Carlow, Committee Chairperson; Elizabeth Forestiere, Student Member; Kelley Heath, Board Member; and James Moses, Board Member were present. Mr. Sargent was excused from the meeting. Others present included Erika Creutz, Board Chairperson (attended remotely via Zoom); Eileen King, MSMA Deputy Executive Director (attended remotely via Zoom); Lori Napolitano, Assistant Superintendent; and Hedy Smith, Executive Secretary.

1. Call to Order

Mr. Carlow called the meeting to order at 8:32 a.m.

2. Public Comment Session

There were no members of the public in attendance who wished to address the Committee.

Miss Forestiere felt that panelists had given their feedback through the numerical rubric. She did not feel that it was necessary to provide another opportunity at this time. Ms. Napolitano stated that with the number of panelists on the interview panel, it would be difficult to develop a process for debriefing. The Committee was in consensus that decisions had been made today based on the rubric information which was provided by the interview panelists. The Committee preferred to move forward.
