Overall the district will be receiving approximately \$386,000 less than the current subsidy with some of the decrease being attributed to declining student enrollment and increasing valuations. Mr. Brockman noted that MSAD 6 subsidy is calculated different than most other school districts in Maine as MSAD 6's is calculation is not based on student enrollment per town but rather town valuations.
